  - 1. Purpose: data that already exists is pulled together to learn new things from the data
  - 2. Center should be open to many participants (i.e. providing workshops, etc.)

#### 4. Program Officer Report (Alice Gibb)

- a. DVM/DCB has the most abstracts submitted at the 2024 meeting
- b. Over 300 oral presentation abstracts across 42 talk sessions submitted from DCB and DVM
  - i. 117 abstracts submitted with DVM as the primary division
- c. Best Student Presentations
  - i. 8 people competing in DVM Best Student Presentation: D. Dwight Davis Award (3 Jan, 1:30-3:30pm, Arch Building, 6th Floor: 615-616)
  - ii. 21 people competing in DVM Best Student Poster: Karel Liem Award (3 & 4 Jan, 3:30-5:30pm, Exhibit Hall 4A)
  - iii. Does DVM want to consider limiting number of participants in poster competition? See discussion notes below.

# 5. SPDAC Report (Adrien Arias)

- a. Mentor/Mentee Data:
  - i. Working with DCB SPDAC rep to improve SPDAC purpose in broader SICB community
  - ii. Jury still out on what to do about social media presence twitter dying, but people are scattered

- across Blu Sky (where people seem to be heading, but barriers), Insta (work-intensive, so that's a barrier)
- iii. Organized mentor-mentee program for 2024 meeting
  - 1. This year, mentors responsible for meeting with mentees and associated costs
  - 2. Would like to have funding to support mentor/mentee interactions (e.g., lunch) would like to get \$500 from DVM and DCB each to support this
  - 3. Feedback: people seem to be generally interested in this program, want to continue program in future years
  - 4. 38 responses this year: pretty even split between mentors/mentees easy to pair folks up
  - 5. Majority of mentees were 1<sup>st</sup> or 3<sup>rd</sup> year PhD students
  - 6. Mentors are primarily Early career academics
  - 7. Majority of mentors/mentees are interested in functional morphology and locomotion
  - 8. Alice Gibb feedback/suggestion: Next SICB, early planning for mentor-mentee program can begin early September when the DVM PO is beginning the meeting planning to avoid difficulties of preparations closer to holidays/conference time in January.

# 8. Comparative Neuromuscular Biomechanics (CNB) Working Group (Taylor Dick and Armita Manafzadeh)

- a. Goals: to accelerate cross-pollination between comparative and human biomechanics fields; international forum dedicated to comparative neuromuscular Biomechanics. And space for animal-and human-focused researchers
- Born at joint symposium of SICB and American Society of Biomechanics – highlighted scarcity of interaction between biological and biomechanics societies; strong interest in increasing interaction among fields
- c. Currently very muscle-centric looking to expand to more comparative and broader systems (mechanics, modeling, bio-machine interfacing; orthopedic biomechanics)

#### 9. Other Business/Discussion

- a. Best Student Presentations (Poster) Limitations
  - i. Challenges: number of posters may need a strategy for determining which posters are in competition (extended abstract or criteria for selection, like we do for oral presentations) – will be more beneficial for students and more manageable for division and judges
  - ii. Any change will need to be voted on because it will require a change to by-laws; changes must be approved by membership vote – vote can be done electronically via spring or fall newsletter

- iii. Discussion: How many posters and how selected?
  - 1. reference: 8 oral presentations
  - 2. Suggestions for 8 to parallel oral competition; also 10 or 12 suggested; Andie suggests 10
  - 3.10 participants selected based on extended abstract assessment by committee
- iv. Motion to amend bylaws to: limit number of competitors in best student poster competition to 10 with extended abstract to mirror BSP oral presentation; limit number of times a student can compete to mirror BSP oral presentation; competition eligibility does not overlap
